Account payable at Delhi.

Fee not deposited by 15<sup>th</sup> September, 2016 may be accepted only upto 30<sup>th</sup> September, 2016 along with late fee of Rs. 20/- (Rupees Twenty only) per day. Thereafter, it will be accepted with the approval of Vice Chancellor, IGDTUW.

Fee shall be received in Indian currency i.e. only in Indian rupee. Further the fee will be received through Bank Draft / Banker's Cheque only to be deposited in Punjab & Sind Bank, IGDTUW Campus, Kahmere Gate, Delhi only.

The Challan / deposit slip will be verified by the concerned HOD / Officer authorized by HOD (IGDTUW) before depositing the fee in the Bank by the student.

All the Heads of the Department, Indira Gandhi Delhi Technical University for Women are requested to furnish course wise list of all students indicating Student Name, Course Name, Enrollment Number, Year of Course and Semester No. etc, duly signed, submitted to Accounts Branch, IGDTUW latest by 30<sup>th</sup> September, 2016 for preparing / maintaining proper books of account of fee and also direct the students for depositing the fee accordingly.
