I. ANNOUNCEMENT OF SPECIAL ADMISSION DRIVE PH.D. PROGRAM: 2022-23

Fresh applications are invited for SPECIAL ADMISSION DRIVE for the few seats that are vacant in the Ph.D. Program. Ph.D. Program at IGDTUW is only for female students. Admission shall be on the basis of Research Aptitude Test (RAT) followed by interview. Applicants who have qualified GATE/NET will be exempted from RAT Exam and will be called directly to appear in interview. IGDTUW Junior Research Fellowship may be offered to few of the selected PhD scholars.

However, the seats so remained vacant due to lack of reserve category candidates shortlisted for Ph.D. interview of special Drive will be de-reserved in the interest to promote research, being an only women University.

II. APPLICATION TO PH.D. SPECIAL ADMISSION DRIVE

The Candidates seeking admission in the PH.D. Special Drive of IGDTUW shall fill up online application form available on website https://igdtuw.in/IGDTUW_ADMISSION/login , pay

the application fee online, upload the necessary documents & signature, and submit the application. The Programme and other details are available on the University website Link <https://igdtuw.ac.in/Admission.php?id=6>

Please note the following: All admissions shall be PROVISIONAL. Admission will stand cancelled in case of failure to pay the full fees and / or submission of required documents within the stipulated time. The University cannot be held responsible for any lost opportunity or loss/damage arising thereof. III. ADMISSION PROCEDURE

Admission to the Ph.D. Program will be common to the two categories (Full time and Part Time) of applicants.

- 1) Admission shall be made on the basis of a written Test viz. RAT followed by an interview.
- 2) The RAT Examination shall be qualifying only with qualifying marks as 50%. A relaxation of 5% marks (from 50% to 45%) shall be allowed for SC/ST/OBC/Differently abled (PD) category to qualify the RAT Exam.
- 3) The syllabus of the RAT examination shall consist of 50% of Research Methodology and 50% subject specific. (Please refer [https://igdtuw.ac.in/uploads/RAT%20EXAM%20SYLLABUS%20\(1\).pdf](https://igdtuw.ac.in/uploads/RAT%20EXAM%20SYLLABUS%20(1).pdf))
- 4) The application fee of Rs. 1000/- deposited by the applicants is **Non-Refundable**.
- 5) The RAT examination shall be waived off for the following applicants subject to the fulfilment of eligibility qualifications, and such applicants shall be allowed to appear in the interview directly:
 - a. Full-Time female teaching staff (Faculty) of IGDTUW.
 - b. Sponsored applicants from organizations having MOU with the University.
 - c. Applicants who have qualified UGC-CSIR-JRF/NET Or have qualified GATE with a score above the minimum cut-off and successfully completed requisite Master's degree.

- d. Foreign students who apply through Ministry of Human Resource Development or foreign students under a Cultural Exchange Scholarship Course of Government of India.
- 6) The exempted category applicants as per point (5), in a subject will not be required to appear for the RAT exam.
- 7) The RAT shall be conducted in the following disciplines:
- Electronics and Communication Engineering (ECE)
 - Computer Science / Information Technology/ Computer Applications
 - Mechanical & Automation Engineering
 - Chemistry
 - Physics
 - Electrical Engineering (under the Department of Electronics and Communication Engineering)
 - Architecture and Planning
- 8) The Syllabi and other related details of the RAT Examination are available on the University website.
- 9) All applicants taking admission in the Ph.D. Program shall be bound by the Ph.D. Ordinances and Regulations of the IGDTUW
- 10) The applicants shortlisted for interview are required to discuss their research interest/ area during the interview. The interview shall also consider the following aspects viz. whether:
- The person should possess the competency for the proposed research.
 - The research work can be suitably undertaken at the University.
 - The proposed area of research can contribute to new/ additional knowledge.

Note: - In addition to above fee structure, the following fee are also required to be paid at the time of admission in all programs: -

- (i) **Security Deposit (Refundable) : - Rs. 5,000/-**
- (ii) **One Time Alumni Fee : - Rs. 2,000/-**
- (iii) **Hostel and Mess fee, if applicable, will be paid separately.**

VI. RESERVATION/RELAXATION FOR PH.D PROGRAM:

Reservation of seats for Scheduled Caste, Scheduled Tribe, OBC-NCL and Differently Abled (PD) applicants will be as per Government rules. Applicants belonging to SC/ST/OBC/Differently abled (PD) Categories will be given 5% relaxation in minimum entry qualification marks. A relaxation of 5% marks (from 50% to 45%) shall be allowed for SC/ST/OBC/Differently abled (PD) category to qualify the RAT Exam.

Candidate will be eligible for final seat allotment subject to verification of all documents at the time of Ph.D. Interview and fulfilling of the eligibility criteria. If the candidate fails to produce any required documents, her candidature is liable to be cancelled. In case, the candidate fails to fulfill minimum eligibility criteria, her admission shall be cancelled and no fee will be refunded. Admission may be cancelled even after seat allotment & submission of fee if any data/document provided by the applicant is found to be incorrect. All the applicants are advised to maintain COVID appropriate behaviour as per Govt. guidelines and general preventive measures during the counseling.
