CIRCULAR

All students of Ph.D/ M.Tech/ B.Tech/ B.Arch and MCA 2nd year onwards are required to deposit their Annual Fee for Academic Year 2017-18 as per the schedule given below :-

- Fee submission without late fee by 01st August to 10th August 2017.
- 2. Fee Submission with late fee fine of Rs 500/- till 20th August 2017.
- Fee submission with late fee fine of Rs. 2000/- till 31st August 2017.

After 31st August 2017, the defaulter students will be required to write an application addressed to the Dean (Academic Affairs) mentioning the reasons for delay, such applications must reach the Dean (Academic Affairs) latest by 04 Sept 17. All such applications will be placed before a committee which on the merit of the case will recommend to allow/or not allow the fee submission to the Hon'ble Vice Chancellor for approval. Students permitted by the Vice Chancellor shall deposit the fee within a week's time with a late fee of Rs 2500/-. Students falling to submit their fee even after the above process will have to seek re-admission in the same year in the next academic session subject of provisions made in clause 6.3 of the second Ordinance of IGDTUW.
